Immigrants Rights

Services

Centro Legal's Immigrants' Rights practice is committed to serving underserved immigrant community members, including individuals in removal proceedings, asylum seekers, families living in poverty, unaccompanied minors, long-term undocumented residents, LGBTQ immigrants, indigenous language speakers and survivors of violent crimes. This year we continued our partnerships with local school districts in order to represent unaccompanied minor students as well as recently-arrived families with children. Our services provide holistic support to our young clients with case management. Centro Legal's Immigrants' Rights practice includes comprehensive, full-service direct representation before the USCIS and the immigration courts, impact litigation, legal rights education and consultations, as well as advocacy. Through continued legal advocacy and support we are able to transform the lives of vulnerable immigrants, ensuring justice, and helping to keep families whole.

Highlight

Centro launched a new and innovative pilot project which implemented new pro se asylum workshops and clinics in partnership with pro bono partners. During the pro se workshops we are providing asylum seekers the tools, education, and knowledge to be empowered and represent themselves in court. Asylum seekers have a fighting chance to defend their case and win protection from deportation.

Because of these workshops, participants have been granted asylum in immigration court while others have been scheduled for future court hearings.

Tenants' Rights

Services

Our Tenants' Rights practice grapples with a pressing challenge: an unprecedented eviction wave sweeping Alameda County and Contra Costa County. This crisis stems from the COVID-19 pandemic's disproportionate impact on low-income and marginalized communities, exacerbated by soaring inflation. While initial support, such as rental assistance and eviction moratoria, helped, these lifelines have mostly vanished, and many marginalized community members now face eviction.

To address this, we employ a multifaceted approach, offering direct representation, legal consultations, community clinics, workshops, and advocacy. During the pandemic, we prioritized educating both communities and organizations about tenants' rights, empowering tenants to assert their rights. This approach prevented many illegal evictions and equipped tenants with accessible resources.

Our efforts have kept numerous families stably housed amid this unprecedented crisis, while also pioneering a more impactful approach to legal services in times of overwhelming demand.

Highlight

Centro Legal is a recipient of pilot project funding from the Sargent Shriver Civil Counsel Act, a prestigious grant through the California Judicial Council that funds projects working towards a right to counsel in eviction cases.

Centro Legal's Shriver Courthouse Intervention Project (SCIP), in partnership with Eviction Defense Center and East Bay Community Law Center, creates robust courthouse-based services and increases full-scope representation to form an essential "safety net" for low-income litigants and increase court efficiencies. Project services include consultation clinics outside of the courthouse. representation at settlement conferences and trials, and improved training in landlord/tenant law for volunteer mediators. Low-income residents of Alameda County face both a justice gap and an intensifying regional housing crisis, which has only increased as we face an eviction wave post-moratorium following the lifting of local COVID-19 eviction moratoria. The need for legal services to address landlord/tenant issues is at an all-time high, and it is critical that Centro continues to provide court-based, same-day representation services.

During its first three years, SCIP has reached 847 tenants. This project is an important and meaningful way to reach and serve our communities.

Workers Rights

Services

Centro Legal's Workers' Rights practice is committed to empowering workers for safe, dignified working conditions. Our client-centered approach prioritizes individuals' unique needs, especially marginalized groups like day laborers, undocumented individuals, indigenous language speakers, monolingual Spanish speakers, and other lowincome workers who often go unheard even though they make up a large part of our workforce.

Our multifaceted approach involves hearing directly from the community through outreach events, surveys, and representation, to equip individuals to stand against exploitative employers and non-compliant workplaces. We seek compensation and improved workplace practices as remedies, but we also strive for broader change through policy advocacy. Our journey towards a more just economy impacts not only individual clients but entire communities, as group cases prompt industry-wide changes and media attention. By supporting courageous individuals in speaking up, we help them secure deserved compensation for their hard work and a sense of wholeness. Highlight

Centro Legal played a pivotal role in the establishment of Oakland's Department of Workplace and Employment Standards, which is tasked with enforcing local wage theft protections and worker protection laws. Our goal is to help strengthen the Department so that it can address cases that would typically be held up at the state level. Nearly every client we meet has faced some form of wage theft. Low-wage workers in California endure wage theft approximately 372,000 times each week, resulting in an annual loss of approximately \$9.27 billion.

To ensure this department is accountable to the needs of low-wage and historically marginalized workers, Centro Legal partners with local community organizations. Together, we engage in meetings with key officials, providing education and advocacy to drive systemic change.

Youth Law Academy

Services

The Youth Law Academy (YLA) is focused on Oakland's Young People of Color, aiming to empower first-generation, low-income students of color and diversify the legal field. Through mentorship, college readiness, and experiential learning, we foster a collaborative and culturally centered community, nurturing resilience and ethical leadership.

In a legal landscape where less than 7% of attorneys represent a community comprising nearly 40% of the population, we bridge the gap by exposing students to professionals who share their backgrounds. Weekly seminars, law school visits, and mentorship with attorneys promote critical thinking and social justice awareness. We offer immediate 1-on-1 support to students and connect parents with vital resources.

YLA's impact extends beyond meeting immediate needs; we are shaping the future of diverse legal scholars and advocates for justice, creating informed communities and ambassadors of our mission.

Highlight

The Diversity Legal Pipeline (DLP) is a crucial program and support network for aspiring law school students, with a particular focus on People of Color (POC) run by our YLA staff. DLP aims to demystify the law school application process and provide a direct pathway, especially for non-traditional applicants who may have encountered barriers to legal education.

Many of our participants are first-generation, undocumented immigrants, returning students, or come from historically marginalized backgrounds. DLP empowers them through various activities, including guest speaker sessions, panels on criminal law, insights from admissions professionals, personal stories from DLP alumni, courtroom visits, and mental health discussions. Intimate interactions with professors enhance their learning and give them first hand insight into imagining a possibility for their future.

DLP's impact is significant, with the goal of guiding all participants successfully through the law school journey. These participants can later become mentors for future students, contributing to a more diverse and inclusive legal profession that reflects society's richness.

Litigation

Services

Thousands of clients come to Centro Legal each year facing unlawful conditions in their homes, their workplaces, or the immigration system. Too often, these violations reflect systemic oppression impacting the community. While litigation alone can't end these injustices, it can have a profound impact as one tool for our clients to assert their rights and improve conditions more broadly.

Recognizing this need, Centro Legal started an affirmative litigation practice a decade ago. Since then, we have represented thousands of clients and class members in over 50 lawsuits, from state courts to the U.S. Supreme Court, fighting against abusive immigration detention and bond practices, tenant harassment and substandard housing, and wage theft and sexual assault at work. Through this litigation, our clients and communities have recovered over \$16 million in judgments and settlements, and brought about direct policy changes, requiring landlords, employers, and governments to eliminate systemic barriers to justice.

Highlight

Rosa worked for years at a food processing factory. Like so many other immigrant, indigenous, and Black workers historically and today, Rosa and her hundreds of coworkers faced dangerously unsafe conditions and wage theft at their workplace. When Rosa made the courageous decision to stand up for their rights by reporting those conditions, the employer fired Rosa and even filed a lawsuit against her in retaliation. Rosa was terrified but committed to justice, so Centro Legal worked with Rosa to get the lawsuit against her thrown out, and instead file a class action lawsuit against the employer for all of the workers.

Following years of litigation, the employer made important changes to its policies and paid over a million dollars to the workers. And Rosa has been so inspired by the process that she is pursuing her own dream to become a social justice attorney, so she can continue fighting for others.
